

# Bouncin' Bears Liability Waiver

**TO PARTICIPATE AT BOUNCIN' BEARS YOU MUST SIGN IN EACH TIME UPON ENTRANCE. SIGNING IN INDICATES THAT YOU HAVE READ AND AGREED TO THE CONDITIONS BELOW.**

In consideration of being allowed to enter the play area and/or participate in any party and/or program at **Bouncin' Bears of Texas (Tamoozi Investments, LLC)**, I acknowledge and agree to the following conditions on behalf of myself and the participants named by me on the sign-in sheet:

I represent that I am at least 18 years old and am the parent or legal guardian of the participant(s) named by me on the sign-in sheet (hereinafter referred to as the "participant(s)"), or I have obtained permission from the parent/legal guardian of the participant(s) to execute this agreement on their behalf.

I, for myself and the participant(s), acknowledge and understand that there are dangers and risks associated with the activities at/by **Bouncin' Bears of Texas**, and agree to assume all risk of personal injury.

I, for myself and the participant(s), and on behalf of my or their heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS Bouncin' Bears of Texas**, their affiliates, shareholders, officers, directors, agents, employees, other participants, property manager, landlord, equipment manufacturers, attorneys and sponsoring agencies from and against any and all claims, damages, or liabilities for any such personal injury, disability, death or damages to person or property resulting, arising out of, or related to our participation in any and all **Bouncin' Bears of Texas** programs, activities, parties, the use of play area and/or inflatable equipment to the fullest extent of the law. I understand and agree that I must supervise my child at all times while in the facility.

I, for myself and the participant(s), acknowledge the risk of exposure to contagious diseases while at **Bouncin' Bears of Texas**, including but not limited to the novel coronavirus (COVID-19), and agree to comply with any procedures or safety precautions **Bouncin' Bears of Texas** may require to limit the spread of such diseases, including denying access to me or my participant(s) if I/they display symptoms of sickness or illness.

In the event of an accident or serious illness, I hereby authorize **Bouncin' Bears of Texas** to obtain medical treatment for me or the participant(s), on my behalf. I hereby hold harmless and agree to indemnify **Bouncin' Bears of Texas** from any claims, causes of action, damages, and/or liabilities, arising out of or resulting from said medical treatment.

**Bouncin' Bears of Texas**, their affiliates, shareholders, officers, directors, agents and employees reserve the right to refuse service to anyone.

I, for myself and the participant(s), consent to the publication of personal pictures, which may be taken by **Bouncin' Bears of Texas** personnel or their representatives. Publication may include, but is not limited to marketing materials and websites.

## Operational Rules

- All guests under 18 years of age must be accompanied by a parent or guardian at least 18 years of age
- **Everyone must remove shoes and wear socks**
- Participants must remove all objects from their pockets (NO WEAPONS)
- No outside food, drink, or coolers
- All food and drinks purchased at Bouncin' Bears must remain at a table
- On all slides, no jumping, flipping, rolling or sliding on feet from the top
- Once you slide you must exit immediately
- **Bouncin' Bears reserves the right to ask any guests who do not follow the rules to leave**
- No running, pushing or shoving
- No wrestling or rough play
- No climbing or hanging from the nets
- No flips
- Parents can help their children on/off the inflatables, adults can sit in a bounce house to be near their children, but should not bounce at the same time the children are bouncing
- Parents **MUST supervise** their children at all times
